I have mentioned in the last newsletter and a discussion at the February 25th JCAA General Membership Meeting that there were public hearings dealing with Recreational Sector Separation and Data Collection Amendment. I hope many of you took the time to attend one of them and submitted your comments by March 20th, which was the deadline. This is the first steps in the process for this amendment. If you really care about fisheries management will affect you and the future. You must get involved and stay actively gathering the most accurate information on the subject to make an educational decision than comment. JCAA Comments on Sector Separation and Data Collection

Subject: Recreational Sector Separation and Data Collection Amendment

JCAA is an association composed of many clubs throughout our state that represents thousands of recreational anglers throughout our state. At a recent meeting, representatives from various clubs discussed Recreational Sector Separation for Summer Flounder, Scup, Black Sea Bass, and Bluefish as well as data collection for recreational anglers.

Our member clubs are unanimously opposed to sector separation. We believe that sector separation is unfair. An example of this is the current bluefish regulations. Kids are often introduced to fishing by catching snapper bluefish from the docks of the bay. Traditionally they would bring home a good amount to eat but are now restricted to only keeping three each. On the other hand, customers of the for-hire fleet are allowed to bring home five blues per person. It is far

harder to locate and catch bluefish from shore than in a boat. If anything, sector separation should be between boat anglers and shore anglers rather than between the private and for-hire fleets. Another example is fluke. It is far more difficult to catch a legal fluke from shore than from a boat. There are people who can't afford to go out on a boat, who would like to bring fish home to eat. Where is the social justice that NOAA was talking about?

Further, sector separation will create in-fighting amongst the two sectors and they will be less likely to work together on other issues. The document states that the amendment would allow each sector to tailor regulations to their particular needs. What that really means is that the for-hire fleet will receive more favorable regulations than private anglers. We understand they need to earn a living, but so do tackle stores, marinas, and other fishing businesses that depend on private anglers. Having different regulations for the two sectors also creates confusion amongst anglers and makes enforcement more difficult for our law enforcement officers. It will also likely lead to more incidents of non-compliance from angry anglers who believe they are being treated unfairly.

We understand that some states already have separate regulations for the for-hire and private sectors for certain species. It should be the prerogative of the individual states to do so, provided they have the data to develop their regulations through conservation equivalency. We believe it would be wrong to force sector separation to each of the states that prefer not to have it.

Should sector separation be pursued, we believe that the Council and Commission should not set limits on the ability to obtain or retain federal for-hire permits. Again, this is about fairness. However, our view on this is tied to our belief that the for-hire fleet must have their own quotas if sector separation is adopted. Lastly, we believe that better data is needed before any sector splits are considered.

JCAA has always supported the collection of more accurate data as it would allow our fisheries managers to better manage our fisheries for sustainability. That would result in quotas and regulations being set with more confidence. They would then more likely be accepted by our recreational anglers.

We would like to see some form of catch reporting by private anglers fishing from a boat as well as those fishing from the shore. However, finding a way to collect valid data may prove to be somewhat

difficult. Mandatory reporting by private anglers would not be well received and with our law enforcement personnel understaffed in many areas, it would likely not be enforced. Mandatory tournament reporting might be more acceptable. However, the data obtained from tournaments would be skewed as tournament anglers catch far more and far larger fish than the average angler. The same goes for volunteer angler surveys as it is usually the more experienced anglers who submit reports.

You need to find some way to collect reports from the average angler. We have the MRIP program but their surveys only capture a very small percentage of anglers and in many cases result in very inaccurate data. Doing more in person surveys might help but with the current government cutbacks, there would likely be insufficient manpower to do this. However, possibly volunteers could be used.

Contacting anglers through state registries or saltwater fishing licenses might be feasible. This could be done similarly as to how data is collected for bluefin tuna. Anglers would be selected randomly to participate in the surveys but only for a specific period of time. A user-friendly format for electronic reporting from a phone or computer would probably be the best option. However, this could be supplemented through phone calls, emails or regular mail. Offering a chance at a reward of some sort for participating would be a good incentive. I am sure that many manufacturers would be willing to donate rods, reels and other tackle for this purpose.

What If Omega Protein Stopped Menhaden Fishing?

As the founder of the conservation organization Menhaden Defenders, I'm often asked this question. In this piece, I'll provide an educated guess about some of the potential effects of Omega Protein ceasing its menhaden fishing operations.

Omega Protein is the last remaining company in the East Coast Menhaden-reduction fishing industry. "Reduction fishing" refers to the process of grinding

fish into fish meal and oil. If Omega Protein were to suddenly halt its harvesting of menhaden, it would shake things up ecologically, economically, and across the industry.



One of the most immediate effects would likely be a rebound in menhaden populations. These small forage fish are a vital food source for many predators, including striped bass, bluefish, tuna, and ospreys. An increase in menhaden would lead to healthier marine ecosystems, cleaner water (as menhaden filter algae, plankton, and other particles), and better conditions for predator fish. This would contribute to a more balanced Atlantic ecosystem and, in turn, improve recreational and commercial fishing.

Omega Protein processes menhaden into fishmeal and fish oil, primarily for use in aquaculture (such as farmed salmon), pet food, and dietary supplements. If they stopped, pet food companies would be forced to find alternative, hopefully sustainable, protein sources. This could drive up pet food prices, impacting pet owners and potentially changing the types of ingredients used in these products.

The cessation of Omega Protein's operations would also result in significant job losses in Reedville, Virginia, where the industry is the primary economic driver. However, the coastwide trap bait sector, which supplies whole menhaden for lobster and crab fishing, might have an opportunity to expand. Local operators could increase their harvests and even invest in processing facilities to meet the rising demand. Without Omega Protein in the lead, smaller bait harvesters could also experience less competition, benefiting both the recreational fishing industry and the local bait sector.

On the flip side, recreational anglers might encounter purse seine netters and spotter planes working inshore and in backwaters. This could lead to localized Menhaden depletion, negatively affecting

gamefish abundance at certain times of the season. In New Jersey, we might even see the return of pound nets along the Bayshore, a traditional method of menhaden fishing.



For lobster and crab fishermen, the long-term benefits could outweigh the challenges. With less pressure from reduction fishing, the bait supply could stabilize, providing more plentiful and affordable menhaden for these fisheries. A healthier marine ecosystem could also result in more food for crabs and lobsters, further benefiting those industries.



In 2024, an investigation looked into the decline of osprey nests along parts of the East Coast. Experts believe the absence of menhaden in key backwater estuaries, a primary food source for ospreys, may be a contributing factor. If Menhaden populations increase, we could see more successful osprey nests, and the same could be true for bald eagle populations. Marine mammals, such as bottlenose dolphins and humpback whales, which also feed on menhaden, would have a more abundant food source. In New Jersey, we've already seen how an increase in menhaden populations has enhanced the coastal experience for boaters, fishermen, and beachgoers over the past decade. Whale watching, along with striped bass and tuna fishing here in the NY/NJ Bight has been spectacular, largely due to the abundance of Menhaden attracted to the nutrient rich Hudson and Raritan River outflows.

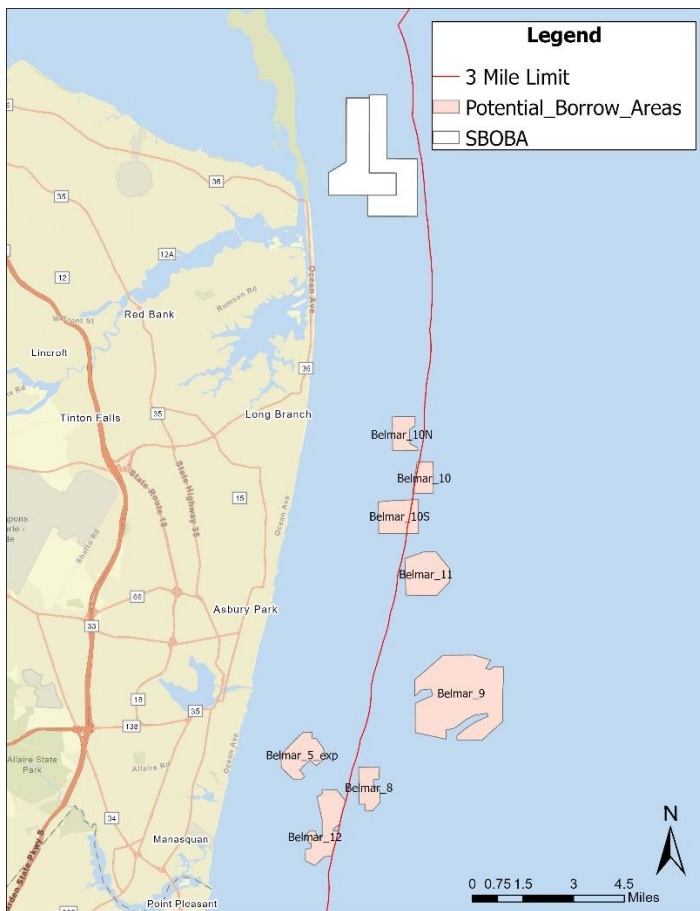
In conclusion, if Omega Protein were to step back from the menhaden fishing industry, coastal ecosystems would likely experience a significant boost. Gamefish, like striped bass and bluefish, along with seabirds and marine mammals, would benefit from a more stable and abundant food supply. As the system gradually returns to a more natural balance, the entire Atlantic coastal ecosystem could thrive. This could be a pivotal moment for coastal communities, marine life, and the fishing industry to collaborate for a healthier, more sustainable future.

US Army Corp of Engineers New Jersey Borrow Areas Information Session

The US Army Corp of Engineers (USACE) held a virtual meeting on March 5, 2025, to discuss potential sand borrow areas in the Atlantic Ocean off of Monmouth County from which to excavate sand for their Sea Bright to Manasquan Coast Storm Risk Management Project (Beach Replenishment) for which they are "authorized" to continue until 2049. I do not believe that this meeting was publicly advertised. I was only made aware of this meeting by John Toth who was advised of it by the USACE because of past communication with them regarding a previous project. There were approximately 20 people on the meeting, not counting USACE personnel. The USACE stated that the purpose of the meeting was to identify to

“stakeholders” several potential sand borrow sites that the USACE could use to obtain suitable to allow them to continue their cycle of beach replenishment projects between Manasquan and Sea Bright until 2049. They explained that the Sea Bright Offshore Borrow Area that they are currently using for sand, is almost exhausted of the proper grain size sand. The sand that is left is either too fine or too coarse. The USACE has identified several potential sand borrow sites, as shown on the attached figure. These sites have to be tested to determine if they contain the proper grain size sand. The USACE intends to begin testing at these sites to determine their suitability for use and begin drawing sand from them by October 2026.



The obvious concern here for JCAA member club members is the impact to recreational fishing, especially for those that fish out of Shark River and Manasquan Inlets.

Opening up the meeting to questions and comments from the public saw a meeting participant, a commercial fisherman, state that several of the areas are adjacent to known fishing areas. The USACE acknowledged this and posted another figure showing the potential sand borrow areas with “Known Fishing Areas” overlaid on the figure. The potential sand

borrow areas are indeed adjacent to and very close to, and in some cases surrounding the known fishing areas. I requested that this figure be provided to me so I could include it with this article but, as of this date, have not received it from the USACE. After several additional questions, along these same lines, the USACE stated that questions and comments on the meeting can be formally submitted to them by email to Jason Shea at jason.a.shea@usace.army.mil.

I sent the following questions to the USACE:

- Was the Information Session publicly advertised, and if so, how?
- Can you please provide a copy of the diagram map on Page 6 that shows the Proposed Sand Borrow Sites together with the Known Fishing Areas?
- Where was the information used to show the Known Fishing Areas obtained from and is it current? Some of the proposed sand borrow areas are immediately adjacent to these known fishing areas. Will a buffer zone be provided? Sand mining in areas immediately adjacent to known fishing areas will negatively impact fishing in these areas.
- Since the USACE intends to continue the cycle of sand replenishment on the beaches between Manasquan and Sea Bright until at least 2049, has there been any investigation into other ways to mitigate sand loss from major storms? Additionally, the USACE ongoing project of sand replenishment results in excess sand being deposited at the northern tip of Sandy Hook and into Sandy Hook Channel. Every year, usually starting in September, this area must be dredged to maintain the navigational channel. This is at the start of prime fishing season and requires access to this portion of Sandy Hook to be closed to fisherman. Can any of this excess sand that must be dredged from the tip of Sandy Hook and the navigational channel be re-used for beach replenishment?

I have not received a response from the USACE as of this date, nor the diagram that I requested. We need to keep monitoring this project. All of the towns between Manasquan and Sea Bright want beach replenishment to continue, but it needs to be performed in a responsible manner that does not negatively impact the interests and activities of others, specifically recreational fisherman.

Fisheries Management & Legislative Report

As newspaper time comes, it makes me reflect. The JCAA lost two friends. We had to cancel the booth at the Atlantic City Boat Show. MAFAC was dissolved. Not a lot of good news.

Booth Canceled at AC Boat Show

I can remember going to the Atlantic City Boat Show as long as I have volunteered with JCAA. Some of you know that I am 77 years old and am not as spry as I once was. We could not find enough people to staff the Atlantic City Boat Show. Last year we sold many raffle tickets at this show and this year we sold none. This was a huge, missed opportunity and might have kept JCAA out of the red if we had been there. We have no young people helping. That means no one under 60. In order to reach out to young anglers, we need young anglers at the booth. I have reached the point where I am the old curmudgeon. It is much easier to relate to people of a similar age. I volunteered with Mark to spend the day and take down the AC Boat Show and the Saltwater Expo because there was no one else to do it. Luckily John Toth was at the Saltwater Expo because I was not much help taking down the booth. We all need to thank Mark Taylor and John Toth. Without them there would have been no presence at the Saltwater Expo. John has spent 7 years as JCAA president and Mark is currently in his 10th year as JCAA president. Collectively they have served for more than 1/3 of JCAA's existence. As Uncle Sam said – "*JCAA needs you.*"

ASA GA Meeting

Mark Taylor and I will be attending the Government Affairs Meeting in May. It is the same time as the ASMFC Spring meeting so others will need to attend virtually. It will be interesting to find out how the manufacturers are dealing with tariffs and other new regulations. ASA and the Fishing and Boating Foundation have been working hard to get a more diverse fishing community and to find new anglers. Some of this is done with federal grants that may disappear. ASA and the manufacturers understand we need to grow the industry by adding more anglers from

every community. We need to train those anglers to become the next advocates for the environment. If you look at JCAA, we became advocates for the environment, sustainable fisheries and for the agencies that protect the right to fish recreationally. Without cultivating the next generation, we will have no one to win those battles.

Striped Bass

The ASMFC will have their first meeting in May for a preliminary discussion for what should go in the next Striped Bass Addendum. I sat in on the most recent Striped Bass meeting that was only for commissioners. There was no opportunity for input from the public. If I was allowed to speak, I would have mentioned that after 5 hours no one discussed the real problem of what was causing the low recruitment in Chesapeake Bay. How can you rebuild the stocks without considering the causes of low recruitment? There was no discussion on new research, on whether this problem was caused by male fish, the impact of the blue catfish, endocrine disruptors, climate change or any of the other environmental impacts. We know all these factors are contributing to the problem, but we continue to focus on the size of the spawning stock biomass which is composed of almost all females. This spawning stock biomass is larger than any that produced the highest young of the year. They are burying their heads in the sand because they don't have the research they need to deal with the other problems. They haven't even talked about what research is necessary. Just continuing to reduce the opportunity to harvest striped bass has not led to good recruitment in Chesapeake Bay. Time for some new ideas. If you read previous JCAA Newspaper articles, you know I was talking about hatcheries, research into these problems and gathering better data. With the current cutbacks in NOAA staff and funding for research, there is no way we will be able to count on the Federal Government for these projects. The states will not have the money since they will be experiencing similar funding cutbacks from the Federal Government. These are scary times.

MAFAC Dissolved

I have been working on environmental justice and climate change for many years. When I saw what was happening at the Federal Government level with firings of personnel my concerns multiplied. When I learned of the beginning cutbacks at NOAA, I realized we were losing people just hired to do the marine recreational

data gathering and to provide better analysis of that data. Then I learned that any initiative that dealt with environmental justice, climate change or diversity would be cancelled.

As you know, I have served on the Marine Fishery Advisory Committee to the Secretary of Commerce for almost 6 years. I would have ended my term in April. I didn't make my termination date. MAFAC, which was established by President Nixon's Secretary of Commerce in 1971, was dealing with climate resiliency, climate change, environmental justice issues and diversity. I have served on those committees. I was not surprised when I got an email from the Secretary of Commerce stating that we had fulfilled our mission (since 1971) and would no longer be in existence. The first thing I considered was that I must have done a great job that MAFAC had solved all of NOAA's problems with the managing of marine fisheries. It is amazing that NOAA no longer needs all the unpaid volunteers who put in their time to find solutions to our NOAA and NMFS ongoing problems. That thought lasted 2 seconds when I realized that NOAA and NMFS are losing all this expertise and diversity of the committee.

I am not going to list the current members, but I have a list of the members from 2016 to the present. If you are interested in seeing the vast expertise and experience of these volunteers, just let me know. This was like serving on a think tank with many brilliant people in their fields. I am always amazed by how I broaden my knowledge on issues and what I have learn from my fellow committee members and NOAA and NMFS staffs. With all our diverse backgrounds, we found ways to work together and build consensus. We put out some valuable white papers, reports and surveys. Whatever your political leanings, we were all able to work together for the common good. I don't know when this great loss will be corrected. I feel sorry for the people where just been appointed to MAFAC eager to contribute. Just to get on MAFAC takes a lot of time and energy.

They became good friends and gained my respect. I hope we can find others to step into their roles and bring the same energy. I know I will miss them both.

Assemblyman John Ronney passes at 85

Assemblyman John Ronney was the longest serving assemblyman when he retired after serving more than 27 years. He was a strong supporter of the environment and worked hard for those important issues all those years he was in the assembly.

NOAA Terminates Space, Climate and Marine Life Advisory Committees

Experts caution the groups play a key role in ensuring agencies use the best available science in their decision making.

The Trump administration is disbanding expert advisory committees focused on space, climate, coastal area management and marine fisheries after the agency they were designed to assist said they are no longer necessary.

The National Oceanic and Atmospheric Administration is ending the committees because they "have served their purpose and should be terminated," Nancy Hann, the agency's deputy undersecretary for operations, said in a memorandum obtained by *Government Executive*. The terminations follow an executive order from President Trump [requiring agencies to do away with](#) any federal advisory committees not required by law. The impacted committees are the:

- Advisory Committee on Excellence in Space
- Climate Services Advisory Committee
- Marine and Coastal Area-based Management Advisory Committee
- Marine Fisheries Advisory Committee

The Commerce Department's Office of Privacy and Open Government, which manages all of the federal advisory committees within Commerce, will work with the committees to ensure "an orderly termination," Hann added.

The space committee, established in 2002, assisted NOAA in assessing the capacity and actions of the commercial sector in space and advises it on avoiding negative impacts on space debris. The climate committee, stood up just before President Biden left office, was established to provide NOAA with advice on making its data and tools better available for those managing droughts, floods, wildfires, heatwaves and other impacts of climate change.

The coastal management committee, also created under Biden, provided expertise on conservation and restoration in coastal and marine areas, including the Great Lakes. The fisheries committee was established in 1971 to provide advice on policies related to living marine resources, including fish, marine mammals, sea turtles, and seabirds and other waterfowl.

Ahead of the terminations, employees involved with the committees were instructed by the Commerce Department to pause any meetings until further notice. A NOAA spokesperson said the termination decisions were made by Commerce and any questions must be directed to the department. Commerce did not respond to a request for comments.

Such councils exist throughout and are governed by the 1972 Federal Advisory Committee Act. They are set up across agencies to gather advice and information from non-federal experts, including

those in academia and the private sector. The General Services Administration provides oversight of the groups to ensure they remain objective and accessible to the public. There are at least 1,000 federal advisory committees throughout government, according to GSA.

Committees not mandated by Congress go through an administrative review of their activities and responsibilities every two years.

Jules Barbati Dajches, an analyst with the Union of Concerned Scientists, said last month that FACs help ensure that "decisions that necessitate the use of science are free from political interference, corruption, and unintentional errors."

"Consisting of experts in their respective fields from academia, local governments, non-profits, and industry, they provide guidance to policymakers on a range of high-stake issues that impact people every day—including their access to clean air and water," Barbati Dajches said. "Advisory committees, groups, and boards bring the public into the work of the government to provide advice in a deeply engaged way."

Barbati Dajches added the committees help agencies identify and utilize the best available science and "provide a reality check to create effective policies."

The Environmental Protection Agency previously fired members of its two science advisory committees and Trump has also signed an order requiring at least one-third of FACs to be dissolved.

Federal DOGE Cuts Under Trump Threaten these NOAA, US Fish & Wildlife Services in NJ

The future of three facilities operated by the National Oceanic and Atmospheric Administration and one U.S. Fish Wildlife ecological field office in New Jersey are in question, after being caught up in the cuts to the federal budget initiated by the Trump administration's Department of Government Efficiency, or DOGE.

It's not clear if the services will be lost, moved to other locations within the state or continue as business as usual. Two of the NOAA facilities are leased office space in Wall and in the Atlantic County

town of Northfield that are used by its law enforcement officers.

Both of the office leases are to be ended, according to the list of [DOGE's real estate lease terminations found on its official website](#). A NOAA spokesperson declined to comment on the future of these operations.

The third NOAA facility, the James J. Howard Marine Science lab at Sandy Hook, is not scheduled to have its lease terminated but [faces a potential cut in funding that could impact its services](#), U.S. Rep. Frank Pallone, D-N.J., told the Asbury Park Press last month.

Pallone, the ranking member of the House Energy and Commerce Committee, said \$5 million in Inflation Reduction Act funding for the lab allocated by Congress is unavailable, which is putting jobs, research and critical infrastructure at the lab at risk. The lab's seawater intake supply infrastructure, essential for the lab's core function, was set to be rehabilitated using IRA funds.

Pallone said the freeze means the system is in jeopardy of total failure by April, when contracts for critical maintenance staff expire.

The possible cuts to the lab have students at Marine Academy of Science & Technology or M.A.S.T. at Sandy Hook concerned for the future of their education.

"The Sandy Hook Lab is a big part of the program. We use it for our junior year Research I class to perform some simple and some complex experiments, but the seniors use the lab to execute their capstone project. Their projects span the entire year, and are extremely impressive," said Cassara Yannarelli, a junior from Atlantic Highlands.

Yannarelli has a summer internship at the lab that could be impacted if the staff is cut that would oversee it.

The final building is the [U.S. Fish & Wildlife Service ecological services office on Jimmie Leeds Road in Galloway Township](#), also in Atlantic County, which according to the General Services Administration (GSA) will have its lease terminated on [Nov. 28](#).

This office works with experts, conservation groups and landowners to protect and recover threatened and endangered species. It coordinates with federal and state agencies, local governments, business and private citizens to make sure that wildlife resources are considered during project planning.

New Jersey Field Office biologists serve on oil spill response teams, investigate the effects of environmental contamination and work to restore polluted habitats. It also collaborates with private landowners to restore fish and wildlife habitats.

Paul Hughes, [a spokesperson for the GSA, which handles real estate, acquisition, and technology services for the federal government](#) said they're reviewing all options to optimize the federal footprint and building utilization.

"We are actively managing lease contracts by leveraging existing contract cancellation rights. As leases enter their soft term, we are sending letters of intent to customer agencies to inform them GSA is considering lease termination, thereby exercising GSA's contractual rights as agreed upon with our lessors," Hughes said.

Hughes said actively managing their leases gives GSA the opportunity to work with its partner agencies on their evolving and longer-term needs and will often allows the GSA to enhance space utilization and secure better terms for the government — including better pricing.

In instances where the current space remains the most suitable option — whether temporarily or longer term — he said they are adjusting their approach. For these agencies, he said they're either rescinding termination notices or, in some cases, not issuing them at all. "These contractual cancellation rights are in accordance with regular and well-accepted private industry contracting processes. GSA's letters of intent to terminate have no immediate effect and do not mean the lease has been terminated," Hughes said.

While not directly addressing the future of the Galloway field office, Laury Marshall, the acting chief of public affairs for the Fish & Wildlife Service, said they remain steadfast in their commitment to serving communities, tribes and conservation partners while upholding federal responsibilities with efficiency and accountability.

Under President Donald Trump, she said the federal government is prioritizing strategic reforms to maximize resources, cut waste and enhance operational effectiveness across our facilities.

"We are actively working with GSA to ensure that every facility and asset is utilized effectively and where necessary, identifying alternative solutions that strengthen our mission. These efforts reflect our broader commitment to streamlining government operations while ensuring that conservation efforts remain strong, effective and impactful," Marshall said.

Dear Secretary Lutnick,

Fisheries and aquaculture are an economic engine in the United States. Fisheries generated \$321 billion in sales impacts and nearly \$150 billion in value-added impacts (NOAA FEUS 2022¹) and aquaculture is a \$1.5 billion industry (NOAA FOTUS 2020²). The future success of U.S. seafood in the global marketplace depends on continuing to lead the world in harvesting sustainable products from healthy oceans and waterways. Hard working Americans are the backbone to this multibillion-dollar seafood industry that NOAA Fisheries supports, and the Marine Fisheries Advisory Committee (MAFAC) is the group of nongovernment citizens supporting NOAA Fisheries in implementing their mission.

MAFAC, established in 1971, predates the modern fisheries management system and exists to provide commercial, recreational, aquaculture, seafood, consumer, tribal, academic, and other interest groups a consistent pathway for input and feedback on NOAA Fisheries policies and programs. The Committee has served under ten consecutive Presidential Administrations on both sides of the political aisle and is available to the Secretary of Commerce and NOAA on an ongoing basis as an industry expert source for consultation during the development of ocean resource policy and agency programs, such as the National Seafood Strategy and the development of NOAA's aquaculture program. The below signed recent and former MAFAC members submit this letter to you in continuation of our shared interest in advising the Department on the management of living marine resources and support for the marine economy.

Sustainable commercial and recreational fishing industries cannot persist into the future without direct support and investment from NOAA. Fisheries and marine resource management is focused on managing a public resource for long-term benefit to the nation.

NOAA and NOAA Fisheries have been developed to provide critical science and services to the communities and industries that depend on these natural resources for their jobs, recreation, and future. NOAA Fisheries collects and provides the data, science, and research that is foundational to U.S. fishing, and supports a uniquely collaborative system that empowers fishermen, state managers, and others to contribute to fisheries management so that decisions are tailored to the needs of fisheries in each region. A disruption to the regular and timely provisioning of these science and service products, whether it be through loss of critical staff and capacity, closing programs and offices, inconsistent science and surveys, or other such cuts will result in direct and lasting harm to seafood businesses, coastal communities, and the American people.

Fishing is a deeply local industry, which makes it essential for NOAA Fisheries to have a presence in coastal communities across the country to understand the regional needs. At the same time, fisheries are influenced by national and international factors that require cross-coordination. These factors combine to mean that NOAA needs the staffing, capacity, and geographic flexibility sufficient to support fishing at all of these scales. The expertise of NOAA's scientists, managers, liaisons, communicators and more helps ensure that NOAA's science and decisions meet the needs of the seafood industry and marine resource-dependent communities around the nation. Because of NOAA Fisheries, the United States has a globally competitive seafood industry that leads the way in standards and quality.

MAFAC's purpose in this system is to be a consistent forum where fishermen, seafood processors, conservationists, aquaculture experts, and scientists can work together to support NOAA Fisheries in solving tough problems facing marine resource management. Above all, the below signed current and former MAFAC members want to deliver the resounding messages we have heard. **American seafood companies and fishing communities need NOAA to be a champion for sustainable U.S. seafood and to fight harder for those businesses, products, and people.** The seafood industry and the American people deserve to have viable fisheries that can support fishing dependent communities across the nation. 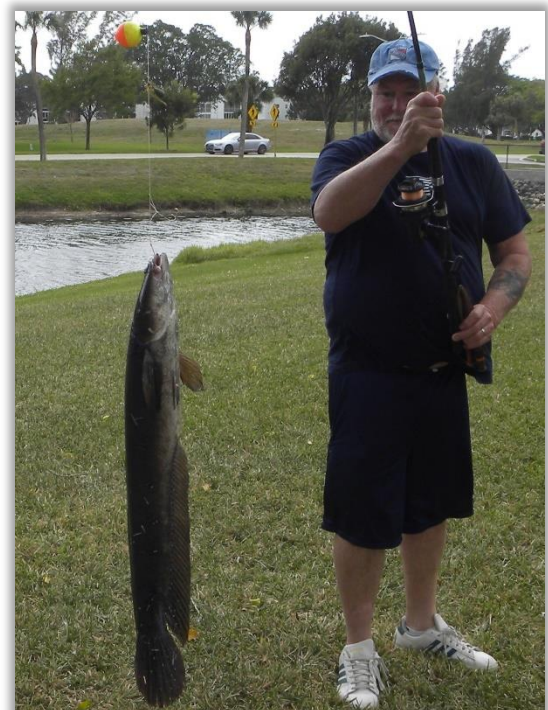
