A Fisherman's Concerns About the NESE Pipeline

I work Raritan Bay, Raritan River, Shrewsbury River and the Navesink River very often. If you live off this water, you know the bottom, the fish, and the tides — and you know when something new might put all that at risk.

The newly approved but not yet final NESE project isn't only about laying 26" pipe under Raritan Bay. It also calls for a big new compressor station in New Jersey (Compressor Station 206) to push gas through the line. Williams/Transco, the pipeline owners, will run the station's turbines and other equipment, and when pressure needs to be released, they do "blowdowns" that send gas and other emissions into the air. The NJDEP application and project pages describe the proposed CS-206 and the offshore pipeline work.



This isn't the only dirty compressor station in the state. Transco already operates compressor facilities in New Jersey — for example Compressor Station 303 in Roseland, Compressor Station 505 in Neshanic Station, and Compressor Station 205 in Mercer County — and other Transco projects and proposals add or change stations around the state. That means New Jersey communities already live and breathe the filth from several compressor sites.

Compressor stations emit nitrogen oxides, particulate matter, and other pollutants from gas turbines, engines, and diesel equipment. These pollutants aren't just air problems — what goes up eventually comes down. Particles and chemical residues settle on shorelines, wetlands, and into the water, where they can stress clams, crabs, baitfish, and the nurseries that feed our sport and commercial fisheries. Studies and regulatory filings show compressor stations are a common source of local air pollution, and public health and environmental reviews flag risks from their emissions.

There's also an unfair geography to this plan. The NESE pipeline moves Pennsylvania fracked gas to supply New York City and downstate New York, while the heavy construction, compressor station, air, and water impacts happen in New Jersey. The gas and market benefits flow to New York customers and pipeline companies, while New Jersey towns and waterfront workers would shoulder a lot of the pollution and risk. That gap — who gets the fuel and who gets the smoke — is something we can't ignore. (Permits and news coverage of the approvals note the primary delivery points and the staging of construction and facilities.)

And here's the part that keeps me up at night: The submarine pipeline installation will dredge up roughly 1 million cubic yards of sediment in Raritan Bay — mud loaded with carcinogenic toxins like dioxin, mercury, lead, arsenic, and copper. Anyone who fishes these waters knows the bay bottom has a long industrial history. When you churn it up, those poisons don't stay put. They enter the fish that we eat. They spread into the water column, pollute and bury shellfish beds, smother juvenile fish habitat, and foul the very nurseries that support fluke, blackfish, weakfish, and striped bass. This isn't just "turbidity." This is toxic sediment re-suspension on a massive scale.

Out in Raritan Bay, crews will also drive piles, hammer and pin pipes into the bottom, and clear routes across productive grounds. Disturbing contaminated sediments can wreck nursery areas where shellfish, fluke, and striped bass grow. Once those grounds are harmed, recovery can take years — and in some cases they never fully bounce back.

I'm not against jobs or keeping the lights on. But I'm tired of seeing the same pattern: Pennsylvania supplies the gas, the pipeline company takes the profit, New York gets the fuel, and New Jersey gets the compressor station, the construction, and the pollution.

We need clear proof — real monitoring, strict limits, and real benefits for the communities taking the risk — before anyone breaks ground. Remember: **you can't rebuild a bay or replace contaminated fish.**

What's next? As the new governor transitions in, we need to clearly express our opposition to this project and ensure the NJDEP understands the very real, very permanent consequences it could have on the bay, the fisheries, and the people who depend on both.

Environmental Advocates Sue NY, NJ over Pipeline Approval

A coalition of environmental nonprofits is suing New York and New Jersey over both states' decisions to green-light a gas pipeline.

The advocates are challenging the New York State Department of Environmental Conservation's and the New Jersey Department of Environmental Protection's approvals of water quality certifications for the Northeast Supply Enhancement Project, which would expand the gas pipeline through Pennsylvania and New Jersey to New York, and supply National Grid customers in New York City and Long Island.

"Playing politics with clean water endangers all New Yorkers," Roger Downs, conservation director of the Sierra Club Atlantic Chapter, said in a statement. "We cannot compromise our laws and scientific principles just to appease the Trump administration's overreach."

Both New York and New Jersey have previously denied water quality permits to the Williams Transco project. The expansion looked all but dead until it was revived by the Trump administration, which is championing fossil fuels over renewable energy generation.

The details: In New York, groups including the Sierra Club, Food & Water Watch, the Natural Resources Defense Council and NY/NJ Baykeeper [filed a lawsuit](#) Tuesday in the 2nd U.S. Circuit Court of Appeals over the DEC's decision to grant a water quality certification. The DEC denied water quality permits for the project in 2018, 2019 and 2020.

In a letter to Transco, the DEC said that granting the water quality permit to the NESE project would violate the state's landmark 2019 climate law's greenhouse gas emissions targets — but that it was

granting the permit anyway due to a "reliability need." Shawn LaTourette, New Jersey's commissioner of environmental protection, told POLITICO's E&E News that Williams had made changes to comply with New Jersey's environmental laws.

"DEC's approval is a 180-degree reversal – in 2020 it denied the exact same application," Susan Kraham, managing attorney for Earthjustice's Northeast region, said in a statement. "There's nothing different in the substance of this application that shows that this project is any more likely to comply with the water quality standards than it was the last time around."

In New Jersey, the Natural Resources Defense Council (NRDC) filed a similar lawsuit, as did groups including the Princeton Manor Homeowners Assn., Central Jersey Safe Energy Coalition and New Jersey League of Conservation Voters Education Fund. They are challenging the DEP's decision to grant a water quality certification to NESE, which the same agency rejected in 2019 and 2020. The Princeton Manor Homeowners Association's homes are within half a mile from the proposed compressor station.

DEC declined to comment on pending litigation, and DEP did not immediately respond to a request for comment.

While such agency decisions are normally challenged in state court, interstate pipelines that are regulated by the Federal Energy Regulatory Commission must be challenged in a federal appeals court under the National Gas Act.

More context: The DEC pipeline approval is just one of several recent actions by New York Gov. Kathy Hochul's administration eliciting ire from environmental advocates, who are also upset by a deal with a gas-powered crypto mining operation and a decision to delay implementation of a law requiring the electrification of new buildings.

Three climate-focused groups, including one of the plaintiffs in the lawsuit, endorsed her primary challenger Lt. Gov. Antonio Delgado this month.

What's next: The project isn't ready to break ground yet; it still needs a 404 permit from the Army Corps of Engineers and needs to submit plans before it can begin construction.

Kraham doesn't expect the case to be briefed before next year and said plaintiffs would consider additional legal action if the project is ready to break ground.

Nick Honachefsky, a major figure in the recreational fishing industry, gave a great speech and pointed out several things that are important. The food was great and plentiful. JCAA gave away a lot of prizes. We had a lot of room for more people and hope to see some of you there next year. It is open to the public, and you might find a club you would like to join.

ASMFC Annual Meeting

I attended the ASMFC Meeting in Dewey Beach and I will cover information from two of the boards I attended. I will include the summaries from the Striped Bass Board and the Tautog Board. I did not include all the motions and the charts. There is a link under the meeting summaries that will give you all the information and all the motions and the tables.

Striped Bass

The Striped Bass Meeting was interesting. Maryland charter Boat Association and the Waterman's Association chartered buses to come to the meeting and almost filled the entire room. The Board finally came to their senses and left us at status quo. I put just the summary, but you should read the motions. They are going to do Amendment 3 and try to figure out what comes next. It was good to attend a Commission Meeting and see many of the commissioners.

Menhaden

The room was packed by the Menhaden reduction boat workers. They came by buses from Virginia. The Atlantic Menhaden Board reduces the 2026 TAC by 20% and initiates an Addendum for Chesapeake Bay

Cap. There should have been more of a reduction but to find out more, go to full release. There were many people who were disappointed. It appears the menhaden fishery doesn't play by the same rules that the Striped Bass Board does. The Technical Committee's data showed the Board that stocks were overestimated. The reduction boats have been harvesting too many menhaden for years. Most people expected the Board to call for a bigger reduction going forward but the Menhaden Board seems to have its own rules. I was not surprised Omega Protein buys enough influence in the legislature in Virginia to insulate them from the rules. For years, Virginia has threatened to leave ASMFC if the Board doesn't treat the reduction boats with Kid Gloves! I know if this was any recreational species and we have this type of overfishing; we would have seen a dramatic cut for several years. I look forward to some articles from JCAA on this very issue. Last month I wrote about Len Fantasia's Menhaden Project in NJ. We need another committee to do the same work coastwide. We need to stop attacking each other and stick together in the recreation community. Striped Bass has put this recreational community at odds, and we need to stop.

Atlantic Menhaden Management Board

Press Release: ASMFC Atlantic Striped Bass Board Approves Addendum III Without Reductions in Fishery Removals

New Work Group Planned to Address Long-Term Management and Stock Concerns

Dewey Beach, DE – The Commission's Atlantic Striped Bass Management Board approved Addendum III to Amendment 7 to the Interstate Fishery Management Plan (FMP) for Atlantic Striped Bass. The Addendum modifies requirements for commercial tagging programs, implements a standard method of measuring total length for size limit regulations, and

allows Maryland to change its Chesapeake Bay recreational season baseline if the state so chooses.

The Board decided not to move forward with the proposed 12% reduction in fishery removals after lengthy deliberation. The Board reviewed the preliminary estimates of 2025 recreational catch through June, which were lower than anticipated and suggested that the projections may have underestimated the probability of rebuilding by 2029 and overestimated the reductions necessary to rebuild. The Board noted that the over 4,000 public comments they received on the draft addendum were sharply divided on the issue, as was the Board itself. Ultimately, the Board maintained current recreational measures and commercial quotas, noting the severe economic consequences of the proposed reduction, the low fishing mortality rate in 2024, and preliminary indications of lower catch in 2025. However, the Board continued to express concern about the seven consecutive years of low recruitment in Chesapeake Bay and the impact on the stock as those weak year-classes become the majority of the spawning stock biomass after 2029. To address this, the Board approved the establishment of a Work Group to consider these upcoming stock and management challenges beyond 2029. The Board will further discuss the specific tasks and timing of this Work Group at subsequent Board meetings.

For commercial tagging, the Addendum requires states to tag commercially harvested fish by the first point of landing. Previously, states could choose the point of tagging, including tagging at the point of sale. This change to when tagging occurs addresses concerns that waiting to tag fish until the point of sale could increase the risk of illegal harvest. The three states that will need to switch their tagging program from point of sale to point of landing have until the end of 2028 to make that change due to the extensive administrative and programmatic transition needed.

For measuring total length, the Addendum specifies that when measuring total length of a striped bass it must be a straight-line measurement with upper and lower fork of the tail squeezed together. This definition applies to both sectors. This new definition addresses concerns that the previous lack of a standard definition was potentially undermining the intended conservation, consistency, and enforceability of the coastwide size limits, especially for narrow slot limits. States that do not have the new definition in place

already have until January 1, 2027 to make changes to their state regulations.

For Maryland's Chesapeake Bay recreational fishery, the Board approved Maryland's ability to change its recreational season baseline (i.e., the timing, type, and duration of striped bass closures throughout the year) if the state so chooses. Maryland is considering changing its season baseline to simplify its Chesapeake Bay regulations as well as re-align access based on stakeholder input and release mortality rates. The new baseline is estimated to be net neutral calculated to maintain the same level of removals as compared to 2024. Maryland will notify the Board of its decision by December 31, 2025 in its state implementation plan.

Meeting Summary

In addition to selecting measures for and approving Addendum III, the Atlantic Striped Bass Management Board received a report from the Law Enforcement Committee (LEC) on commercial tagging.

The LEC was tasked with reviewing the Plan Review Team's Commercial Tagging Ten-Year Review Report and discussing any further LEC recommendations on point of tagging and potential improvements to state tagging programs. The LEC discussed that the current state programs are effective and each in their own way offer a level of protection to the resource and meet the spirit of the FMP. On point of tagging, the LEC noted that management measures in the ocean fishery creating different size and possession limits between sectors gives law enforcement the ability to clearly define a commercial take from a recreational take, which reduces the enforcement concern in a point-of-sale program. Point of sale or point of landing tagging is less desirable for enforcement in states that are managed through individual quotas, and/or that allow for multiple commercial limits on board a vessel, or that have overlapping size limits between the commercial and recreational fishery. In these instances, states should strongly consider point of harvest tagging. If a point of landing provision were to be considered more widely, law enforcement would recommend that a clear and consistent definition of landing be used. On tag distribution, the LEC does not have any major concerns

with how states are managing their respective tag distribution. On tag accountability, the LEC noted all jurisdictions have a process in place to account for the lost, damaged, or delinquent tags. For potential improvements to state tagging programs, the LEC noted the importance of being able to trace a tag back to the harvester.

Tautog Management Board

Press Release: Tautog Regional Assessments Update Shows Varied Stock Status by Region

Dewey Beach, DE – The Commission's Tautog Management Board reviewed the results of 2025 Regional Stock Assessments Update, which found stock status varied by region. Tautog were not overfished in the Massachusetts-Rhode Island (MARI), Long Island Sound (LIS), and New Jersey and New York Bight (NJ/NYB) regions, but were overfished in the Delaware-Maryland-Virginia (DMV) region. Tautog were not experiencing overfishing in the MARI or LIS regions but were experiencing overfishing in the NJ-NYB region and DMV region.

Stock status did not change for the MARI or LIS regions from the 2021 update but did change for the NJ-NYB and DMV regions. The NJ-NYB region went from being overfished but not experiencing overfishing in the 2021 update to not being overfished but experiencing overfishing in this update. The DMV region was previously not overfished or experiencing overfishing but was considered overfished and experiencing overfishing in the 2025 update.

All regions showed patterns in fishing mortality and spawning stock biomass (SSB), with MARI, LIS, and NJ-NYB assessments overestimating fishing mortality and underestimating SSB, while the pattern was reversed in the DMV region, compared to the 2021

update. Based on the [Commission's policy](#), the Stock Assessment Subcommittee adjusted both fishing mortality and SSB for all regions to account for this pattern, which changed stock status for some regions.

Since the 2021 update, recruitment has increased in the LIS and NJ-NYB regions, and MARI shows a slight increase in SSB. In the DMV, fishing mortality had been low since 2012 before reaching a peak in 2021 followed by a sharp decline thereafter. Total removals have increased in all regions, driven primarily by increases in recreational harvest.

In response to the assessment findings, the Board initiated an addendum to address changes in stock status for NJ/NYB and DMV. The Draft Addendum will also consider allowing for the MARI and LIS regions to modify management for precautionary or alignment purposes.


